

District court of Iraklion

Proceeding of unsolicited jurisdiction

Number of enactment 1235/4306/1251/2007

The single court of the district court of Iraklion

Consists of the justice *Ekaterini Keramida* (the regular judges were prevented) who was ordered by the chairman of the board of administration of the district court of *Iraklion*, has heard the case of acknowledgement of an association in a public meeting on the 10th of October 2007 in presence of the secretary *Evageli Kounali*.

Requester:

1) *Christoforos Zachariadis*, 2) *Stratos Fountoulakis*, 3) *Ute Kluge*, 4) *Dagmar Harmsen*, 5) *Marita Gandler*, 6) *Heinz Eikamp*, resident in *Arkalochori*, members of the interim steering committee of the association with the name "ΝΑΟΜ ΤΟΠΙΚΗ ΟΜΑΛΑ ΕΡΓΑΣΙΑΣ ΓΙΑ ΤΟ ΠΕΡΙΒΑΛΛΟΝ ΤΗΣ ΚΡΗΤΗΣ" (NAOM Landesgruppe Umwelt Kreta (NLUK)) with domicile in *Iraklion*, represented by their attorney *Thomas Sapountzakis*.

The requesters apply for the acceptance of their proposal from the 30th of July 2007 (submitted in the office of the court under the number 4306/EM/1251/30.07.2007 and schedules for the date specified above).

The authorised proxy expressed his arguments and placed his requests during the hearing.

The court audited the pleadings from which follows that the requesters apply for the acceptance of the above named association and its registration within the register of association of this court in *Iraklion*. Posed in the context of the unsolicited jurisdiction the request has been placed for the reason of competence of this court (Article 739/740 clause 1 No. a and 787 of GZPO) and is acceptable based on the regulations of Article 12 of the Greek Constitution, 78 ff of GrZGB and the law 2725/1999 as this has been modified by G. 2858/200, G. 3057/2002 and G. 3262/2004. For this reason it must be examined now whether the request is justified.

In accordance to Article 79 of the GrZGB the applicants have acted correctly and submitted the following documents: 1.) the formation minutes of the association from the 9th of May 2007 and the vote of the interim steering committee including the list of names of the interim steering committee, 2.) the articles of association from the 9th of May 2007 which contains 14 articles, dated and signed by the twenty-five (25) founder members. The article contains all data needed based on Article 80 of the GrZGB. It is proven that all conditions planned by the law were kept. Purpose of the association is the communication of information and knowledge to environmental protection to humans on Crete by research and studies in all scientific ranges for the keeping of an intact and healthy environment to well-being of the public of Crete. This purpose is non-profit and does not contradict the valid right, the customs and the public order.

Consequently the request is justified and it is enact, what is designated within Article 81 exp. 1 of the GrZGB.

For these reasons

The request will be grant.

It is enact: 1.) a summary will be published within a daily paper in *Iraklion* as well as within the booklet of *Tameio Nomikon*. The summary must contain the substantial components of the statute from the 9th of May 2007 of the association with the name "ΝΑΟΜ ΤΟΠΙΚΗ ΟΜΑΛΑ ΕΡΓΑΣΙΑΣ ΓΙΑ ΤΟ ΠΕΡΙΒΑΛΛΟΝ ΤΗΣ ΚΡΗΤΗΣ" (NAOM Landesgruppe Umwelt Kreta (NLUK)), 2.) to register the association within the register of association which is with this court.
